

**PROSSER TRANSPORTATION BENEFIT DISTRICT**

**ORDINANCE NO. 09-TBD-05**

AN ORDINANCE OF THE PROSSER TRANSPORTATION BENEFIT DISTRICT ADOPTING A BUDGET FOR 2010 AT THE FUND LEVEL. THE ORDINANCE ALSO SETS FORTH THE EFFECTIVE DATE OF THE ORDINANCE AND PROVIDES THAT ITS PROVISIONS ARE SEVERABLE FROM ONE ANOTHER AND PROVIDES FOR PUBLICATION BY SUMMARY.

**WHEREAS**, the Treasurer of the Prosser Transportation Benefit District, completed and placed on file with the Secretary of the Prosser Transportation Benefit District and with the Board of the District, a proposed budget and estimate of the amount of monies required to meet the general expenses and expenses of government for District for the fiscal year ending December 31, 2010; and,

**WHEREAS**, neither RCW Chapter 36.73 nor RCW 35.21.225 provide direction regarding how a Transportation Benefit District is to organize its finances or prepare and file a budget; and

**WHEREAS**, the District has determined that the best course of action to organize its finances and adopt a budget is to follow the process required for the City of Prosser to adopt its annual budget; and

**WHEREAS**, the Transportation Benefit District has followed the procedural requirements for a non-charter code city to adopt its Budget for 2010 and all notices were published and all public hearings held as required by law giving citizens within the District an opportunity to be heard upon said budget; and

**WHEREAS**, after conducting a public hearing, the Board of the City of Prosser Washington Transportation Benefit District finds it is in the best interest of the District to adopt the budget at the fund level as set forth below;

**NOW, THEREFORE, THE BOARD OF THE CITY OF PROSSER WASHINGTON TRANSPORTATION BENEFIT DISTRICT, DO ORDAIN AS FOLLOWS:** **Section 1.** Adoption of Budget. The budget for the Prosser Transportation Benefit District for the fiscal year 2010 is hereby adopted at the fund level for all funds, in its final form and content as set forth in the document entitled 2010 Final Budget, a copy of which is on file in the Office of the Secretary of the District. The Treasurer is hereby authorized to make transfers and adjustments to and between individual appropriations within any one fund during the current fiscal year by order of the Chair of the District, subject to the provisions of RCW 43.09.210. Estimated resources, including fund balances or working capital for each separate fund, and aggregate totals for all such funds combined for the fiscal year 2010 are set forth in summary form below, and are hereby appropriated for expenditure at the fund level during the fiscal year 2010:

**Section 2.** The Secretary is hereby directed to transmit a copy of the budget to the Office of the State Auditor, Association of Washington Cities, and to Municipal Research and Services Center of Washington.

**Section 3.** The effective date of the 2010 Final Budget shall be January 1, 2010.

**Section 4.** The provisions of this ordinance are hereby declared to be severable. If any section, subsection, sentence, clause, or phrase of this ordinance or its application to any person or circumstance is for any reason held to be invalid or unconstitutional, the remainder of this ordinance shall not as a result of said section, subsection, sentence, clause, or phrase be held unconstitutional or invalid.

**Section 5.** Effective Date. This ordinance shall take effect on the latter of January 1, 2010, or five (5) days after passage and publication of an approved summary thereof consisting of the title.
